Subject: Release of fourth installment of Grants-in-aid during 2017-18 to the State of Himachal Pradesh for implementation of Supplementary Nutrition Programme (SC Component) for 4th Quarter during 2017-18-reg.

Sir,

I am directed to convey the sanction of the President to the payment of Rs.5,31,26,000/- (Rupees Five crore thirty one lakh and twenty six thousand only) as fourth instalment of grants-in-aid during 2017-18 towards GOI's share for implementation of Supplementary Nutrition Programmme for 4th Quarter of 2017-18 under the Anganwadi Services Scheme to the State of Himachal Pradesh.

- 2. The State must immediately undertake a head count of the beneficiaries so that the number of ghost beneficiaries is eliminated. The ministry will be undertaking surprise checks at the anganwadi level in the State throughout the year and any short-coming found in the system of feeding the beneficiaries shall lead to curtailment to state's grants. No further funds over and above the amount approved in APIP will be released/reimbursed on account of SNP to the State.
- 3. Anganwadi Services Scheme is Centrally Sponsored Scheme in which the Centre and States/UTs both have contributions. In the above release, the Centre and States contributions have been calculated on 90:10 ratio and the sanction of funds is subject to the following conditions:
 - i. the amount of grant will have to be utilized for all the components under the Scheme as per the schematic norms;
 - ii. the States/UTs shall also be required to contribute adequate amount for implementation of the Anganwadi Services Scheme.
- 4. The sanction of funds is also contingent upon States/UTs ensuring e-procurement of goods and services under Anganwadi Services Scheme. The advisory in this regard has already been issued to all States/UTs vide circular No.19-37/2015-CD-I dated 09.07.2015.
- 5. The expenditure is debitable to the `3601"- Grants-in-aid to State Governments (Major Head); 06- Centrally Sponsored Schemes (Sub Major Head), 06.789- Scheduled Castes Component, 42 Anganwadi Services,

- 6. The amount of grant-in-aid is finally adjustable in the books of the Principal Pay and Accounts Office, Ministry of Women & Child Development, D, Wing, Ground Floor, Shastri Bhawan, New Delhi. The payment of the State would be arranged through the Reserve Bank of India, Nagpur. The State Accountant General will send intimation regarding receipt of grant-in-aid to the Principal Pay & Accounts Office, Ministry of Women & Child Development, Shastri Bhawan, D Wing, Ground Floor, New Delhi.
- 7. The States shall maintain separate accounts and furnish information on actual expenditure incurred on supplementary nutrition every quarter. The information on expenditure on supplementary nutrition from 1st April to 30th June must be furnished by 15th July and for the period from 1st July to 30th September by 15th October and from the period from 1st October to 31st December by 15th January and from 1st January to 31st March by 15th April to enable the Department to work out the entitlement of Central assistance of each State Government/UT Administration.
- 8. This sanction issues with the concurrence of IFD vide their Dy.No. CD-II-14/31/2015-CD-II /JS&FA dated 31.01.2018.
