Subject: Integrated Child Development Services (ICDS) Scheme - Release of Grants-in-aid to the State Governments during 2017-18 towards GOI's share on **ICDS (General) for (ST component)** for continued implementation of the Scheme – 1st Instalment.

Sir,

I am directed to convey the sanction of the President to the payment of Rs.21,80,63,000/- (Rupees Twenty one crore eighty lakh sixty three thousand only) to the State Governments as indicated in column 3 against each as first installment of grant-in-aid during 2017-18 for the continued implementation of Integrated Child Development Services (ICDS) Scheme:

2. ICDS is Centrally Sponsored Scheme in which the Centre and States/UTs both have contributions. In the above release, the Centre contributions have been calculated on 90:10 ratio and the sanction of funds is subject to the following conditions:

- i. The amount of grant will have to be utilized for all the components under the Scheme as per the schematic norms;
- ii. the States/UTs shall also be required to contribute adequate amount for implementation of the ICDS Scheme.
- iii. Payment of Honorarium to Anganwadi Workers and Helpers shall be made with effect from 01.04.2017 in accordance with the Notification S.O.347(E) dated 06.02.2017 issued under Section 7 of Aadhaar Act, 2016.

3. The sanction of funds is also contingent upon States/UTs ensuring e-procurement of goods and services under ICDS Scheme. The advisory in this regard has already been issued to all States/UTs vide circular No.19-37/2015-CD-I dated 09.07.2015.

4. The expenditure is debitable to the '3601'– Grants-in-aid to State Governments (Major Head) in Demand No. 99, Ministry of Women & Child Development under sub-head; 06- Centrally Sponsored Schemes (Sub Major Head), 06.796- Scheduled Tribe Component, 45 - Anganwadi Services, 45.00.31-Grants-in-aid General 2017-2018 (Plan).

5. The amount of grant-in-aid is finally adjustable in the books of the Principal Pay and Accounts Office, Ministry of Women & Child Development, Shastri Bhawan, New Delhi. The payment of the State would be arranged through the Reserve Bank of India, Nagpur. The State Accountant Generals will send intimation regarding receipt of grant-in-aid to the Principal Pay & Accounts Office, Ministry of Women & Child Development, Shastri Bhawan, New Delhi.

6. The State/UT shall maintain separate accounts and furnish information on actual expenditure incurred on ICDS (General) every quarter. The information on expenditure on ICDS (General) from 1st April to 30th June must be furnished by 15th July and for the period from 1st July to 30th September by 15th October and from the period 1st October to 31st December by 15th January and from 1st January to 31st March by 15th April to enable the Ministry to work out the entitlement of Central assistance of the State Government/UT Administration.

7. This sanction issues with the concurrence of IFD vide their Dy.No. CD-II-14/4/2017-CD-II dated 20.04.2017.
