Subject:- Release of Ist tranche of IInd instalment (IIIrd Quarter October to December 2023) of Central Assistance under the scheme of Indira Gandhi National Old Age Pension Scheme (IGNOAPS) of National Social Assistance Programme (NSAP) for the financial year 2023-24 to **Himachal Pradesh State.**

Sir,

I am directed to convey the sanction of President of India to the payment of **Rs. 737.73 Lakh (Rupees Seven Crore Thirty Seven Lakh and Seventy Three Thousand Only)** to the **Himachal Pradesh State** which includes 3% Administrative Fund of **Rs. 21.49 Lakh** (out of which **Rs. 3.58 Lakh** is earmarked for conducting Social Audit) as Central Assistance for the implementation of Indira Gandhi National Old Age Pension Scheme (IGNOAPS) Under National Social Assistance Programme during the Current Financial Year 2023-24. No Utilisation Certificate is pending in respect of National Social Assistance Programme for the year 2022-23 in respect of the State.

**2. The State Government must transfer these funds to the concerned SNA's account within a period of 21 days of its receipt. In case of non-transfer within the stipulated 21 days, Central Government may be constrained to stop further releases. 3. The grant is towards the Revenue expenditure and will be utilized for payment of assistance to the beneficiaries covered Under IGNOAPS. The funds released Under IGNOAPS shall not be utilized for any other schemes Under NSAP. The amount now released is inclusive of the 3% administrative expenditure. Separate Utilisation Certificate for the funds released for IGNOAPS shall be furnished. No deviation from the provisions of the guidelines is permissible.

4. The Accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Office of the Chief Controller of Account of the Ministry in terms of Rule 236(2) of the General Financial Rules.

5. The expenditure is debitale to the following Heads of Accounts under Demand No. 87, Department of Rural Development (2023-24).

7. This issues under the powers delegated to this Ministry and in consultation with the Integrated Finance Division vide their **U.O. No. 1420/Finance/2023-24 Dated 28-03-2024**.

8. The Utilization Certificate for the Financial Year should include the interest accrued. Interest accrued should be computed based on the details of ledger accounts maintain for the purpose.
