Subject: - Release of pending liability of 2022-23 & Ist tranche of Ist instalment (Ist Quarter -April to June 2023) of Central Assistance Under the scheme of Indira Gandhi National Widow Pension Scheme (IGNWPS) of National Social Assistance Programme (NSAP) for the financial year 2023-24 to Himachal Pradesh State.

Sir,

I am directed to convey the sanction of President of India to the payment of **Rs. 717.17 Lakh (Rupees Seven Crore Seventeen Lakh and Seventeen Thousand Only)** to the Himachal Pradesh State (**Rs. 573.74 Lakh for pending liability 2022-23 & Rs. 143.43 Lakh for Ist Quarter 2023-24**) which includes 3% Administrative Fund of **Rs. 20.89 Lakh** (out of which **Rs. 3.48 Lakh** is earmarked for conducting Social Audit) Central Assistance for the implementation of Indira Gandhi National Widow Pension Scheme (IGNWPS) Under National Social Assistance Programme during the Current Financial Year 2023-24. No Utilisation Certificate is pending in respect of National Social Assistance Programme for the year 2021-22 in respect of the State.

2. The State Government must transfer these funds to the concerned SNA's account within a period of 21 days of its receipt. In case of non-transfer within the stipulated 21 days, Central Government may be constrained to stop further releases. The State Government is requested to endorse the copy of the release order to the Central Government addressed:-

3. The grant is towards the Revenue expenditure and will be utilized for payment of assistance to the beneficiaries covered Under IGNWPS. The funds released Under IGNWPS shall not be utilized for any other schemes Under NSAP. The amount now released is inclusive of the 3% administrative expenditure. Separate Utilisation Certificate for the funds released for IGNWPS shall be furnished. No deviation from the provisions of the guidelines is permissible.

4. The Accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Office of the Chief Controller of Account of the Ministry in terms of Rule 236(2) of the General Financial Rules.

5. The expenditure is debitable to the following Heads of Accounts Under Demand No. 87, Department of Rural Development (2023-24).

3601 - Grants-in-Aid to State Govt. (Major Head)

06 – Centrally Sponsored Scheme

101 – Social Central assistance/Share

26 - National Social Assistance Programme

26.03 - National Widow Pension Scheme

26.03.31 - Grants- in –Aid General

6. DDO NSAP, New Delhi (208039), Ministry of Rural Development will be the Drawing & Disbursing Officer for the purpose. PAORD is requested to transfer this fund through RBI advice.

7. This issues Under the powers delegated to this Ministry and in consultation with the Integrated Finance Division vide their **U.O. No. 703/Finance/2023-24 Dated 29-11-2023**.

8. The Utilization Certificate for the Financial Year should include the interest accrued. Interest accrued should be computed based on the details of ledger accounts maintain for the purpose.

9. The next release of fund to the state will be released only after utilisation of 75% of available fund.
