The funds released under IGNOAPS shall not be utilized for any other schemes under NSAP. The amount now released is inclusive of the 3% administrative expenditure. Separate Utilisation Certificate for the funds released for IGNOAPS shall be furnished. No deviation from the provisions of the guidelines is permissible.
