Sir,

The undersigned is directed to convey the sanction of President of India to the Payment of **Rs. 465.17 Lakh (Rupees Four Crore Sixty Five Lakh Seventeen Thousand Only) to the Himachal Pradesh State** (as per list at **Annexure -I**) as Central Assistance for providing 1st instalment of ex-gratia payment of Rs.500/- to the beneficiaries of Indira Gandhi National Old Age Pension Scheme (IGNOAPS) under National Social Assistance Programme.

2. The amount of ex-gratia is in addition to the amount of central assistance provided to the State/UTs in two six monthly instalments for disbursement of monthly pension/benefit to eligible beneficiaries. Funds for 01st instalment of 2020-21 will be released to State as per the guidelines of NSAP.

3. The State Government must transfer these funds to the beneficiaries through Direct Benefit Transfer (DBT) through Implementing Department of the programme within 3 days positively from the date of receipt of these funds. In case of non transfer beyond this period, Central Government may be constrained to stop further releases. Besides, the State Government would be liable to pay interest @ 12% for the period of delay beyond the specified period. The State Government is requested to endorse the copy of the release order to the Central Government addressed as under:-

4. The grant is towards the Revenue expenditure and will be utilized for payment of assistance to the beneficiaries covered under IGNOAPS. The funds released under IGNOAPS shall not be utilized for any other schemes under NSAP. State is required to submit a separate Utilization Certificate for the above amount. No deviation from the provisions of the guidelines is permissible.

5. The Accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Office of the Chief Controller of Account of the Ministry in terms of Rule 236(2) of the General Financial Rules.


