The funds released Under IGNOAPS shall not be utilized for any other schemes Under NSAP. The amount now released is inclusive of the 3% administrative expenditure. Separate Utilisation Certificate for the funds released for IGNOAPS shall be furnished. The fund should be utilized for payment of benefit to the Schedule Caste beneficiaries of Indira Gandhi National Old Age Pension Scheme (IGNOAPS). No deviation from the provisions of the guidelines is permissible.

4. The Accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Office of the Chief Controller of Account of the Ministry in terms of Rule 236(2) of the General Financial Rules.
