Sir,

The Undersigned is directed to convey the sanction of President of India to the payment of **Rs. 17.78 lakh (Rupees Seventeen Lakh and Seventy Eight Thousand Only)** to the **Himachal Pradesh State** as Central Assistance for the Schedule Tribal beneficiaries of Indira Gandhi National Widow Pension Scheme (IGNWPS) Under National Social Assistance Programme during the Current Financial Year 2021-22. No Utilisation Certificate is pending in respect of National Social Assistance Programme for the year 2019-20 in respect of the State.

2. The State Government must transfer these funds to the Implementing Department for programme implementation within 3 days positively from the date of receipt of these funds. In case of non transfer beyond this period, Central Government may be constrained to stop further releases. Besides, the State Government would be liable to pay interest @ 12% for the period of delay beyond the specified period. The State Government is requested to endorse the copy of the release order to the Central Government addressed as Under:-

3. The grant is towards the Revenue expenditure and will be utilized for payment of assistance to the beneficiaries covered Under IGNWPS. The funds released Under IGNWPS shall not be utilized for any other schemes Under NSAP. The amount now released is inclusive of the 3% administrative expenditure. Separate Utilisation Certificate for the funds released for IGNWPS shall be furnished. The fund should be utilized for payment of benefit to the Schedule Tribal beneficiaries of Indira Gandhi National Widow Pension Scheme (IGNWPS). No deviation from the provisions of the guidelines is permissible.

4. The Accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Office of the Chief Controller of Account of the Ministry in terms of Rule 236(2) of the General Financial Rules.

5. The expenditure is debitable to the following Heads of Accounts Under Demand No. 86, Department of Rural Development (2021-22).




