Sir,

I am directed to refer to State Government of Himachal Pradesh letter No. Home-(A)B(1)/2008-1 dated 27.10.2016 on the above subject and to say that this Ministry had vide letter No.16011/20/2005-PF.IV(ii) dated 31.01.2008 conveyed sanction of the President for raising of 4th IR Bn by the Government of Himachal Pradesh at a total cost not exceeding ₹ 12.75 crore (75% of the standard cost of raising i.e. ₹ 17.00 crore) and besides, 50% of the capital cost (excluding cost of land) subject to a maximum of ₹ 8.00 crore on submission of requisite details regarding expenditure incurred on infrastructure. So far, ₹18.25 crore (₹ 12.75 crore as standard raising cost share + ₹ 5.50 crore as infrastructure cost share) has been reimbursed. Now the Government of Himachal Pradesh has submitted claims for an amount of ₹ 2.50 crore and requested for release of fund.

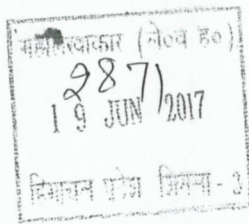
2. Sanction of the President is hereby conveyed for payment of an amount of ₹ 2.50 crore (Rupees two crore fifty lakh only) to Government of Himachal Pradesh as final infrastructure cost share for 4th IR Bn.

3. The above amount is debit to Major Head 3601-Grants-in-aid to State Governments-(Major Head) -08.111- Special Assistance (Minor Head) -05-Grants/Re-imburement for Police Related Expenses- 05.02- India Reserve Battalions-05.02.31- Grants-in-aid-General under Demand No.48 - Police for the year 2017-18.

4. This issues with the concurrence of Integrated Finance Division of this Ministry vide their Dy. No.3090394/Fin-VI/2017 dated 6th June 2017.
