Clarification regarding Interim Relief.


Sir,

I am directed to refer to the subject cited above and to say that clarification is being sought by various departments relating to grant of Interim Relief to such re-employed persons who have been the beneficiaries under New Pension Scheme while in service. The Interim relief has been granted @5% of basic pay (pay in the pay Band+ Grade Pay) to the regular employees of the State Government and pensioners w.e.f. 01-08-2016 vide O.M. No.Fin(PR)B(7)-1/2016 dated 2<sup>nd</sup> August, 2016 and Fin(Pen)B(10)-6/98-III dated 2<sup>nd</sup> August, 2016.

The matter was under consideration of the Government for sometime past. After consideration, it has been decided that the Interim relief will not be admissible for such re-employed persons who have been beneficiaries under New Pension Scheme.

These instructions may be brought to the notice of all concerned.
