Sir,

I am directed to refer to the subject cited above and to convey the sanction of the President of India for the payment of Grants-in-Aid amounting to Rs. 30.00 lakhs (Rupees Thirty Lakh only) to the State of Himachal Pradesh under "ESVHD" a component of 'Livestock Health and Disease Control' ~~ESVHD~~ of Central assistance with the condition that 10% matching share will be provided by the State Government for strengthening of 04 nos. of veterinary Hospitals and 02 nos. of Veterinary Dispensaries, in the aspirational districts of Chamba, Himachal Pradesh under ESVHD for the year 2018-19.

2. The Grants-in-Aid of Rs. 30.00 lakhs (Rupees Thirty Lakh only) have been released in accordance with the approved pattern of financial assistance under the Scheme. The release to the Himachal Pradesh State Government is subject to the condition that the next instalment for release will be considered only after obtaining the information relating to fund-utilization and submission of Utilization Certificate by the Himachal Pradesh State Government.

3. The expenditure will be debited to the following Head of Accounts:


