Subject: Centrally Sponsored Scheme "Peste des Petits Ruminants – Control Programme"(PPR-CP), a component of 'Livestock Health and Disease Control' – Release of Central Assistance during the year 2018 – 19 to the State Govt. of Himachal Pradesh – regarding.

Sir,

I am directed to refer to the subject cited above and convey the sanction of the President of India for payment of Grant-in-Aid amounting to Rs 7.70/- lakhs (Rupees seven lakhs and seventy thousand only) to the State Govt. of Himachal Pradesh towards expenditure on the Centrally Sponsored Scheme "Peste des Petits Ruminants – Control Programme" (PPR-CP), a component of 'Livestock Health and Disease Control' for the current financial year 2018-2019) with the condition that 40% share will be provided by the State Government. The funds have been released to implement the Special Component Plan for Scheduled Castes.

2. The Grants-in-aid of Rs 7.70/- lakhs (Rupees seven lakhs and seventy thousand only) have been released in accordance with the approved pattern of financial assistance under the scheme. The release to the State Government of Himachal Pradesh has been made with condition that the next instalment for release will be considered only after obtaining the information relating to fund utilization and submission of Utilization Certificate by the State Government of Himachal Pradesh.
