4. The payment sanctioned is subject to adjustment on the basis of audited figure of expenditure in terms of Ministry of Finance letter No.2(9)/P II/60 dated 09.10.1964. The Utilization Certificate/ actual figures of expenditure duly audited by the Accountant General may be furnished to this office as early as possible.

The Grant-in-aid is sanctioned on the conditions that this will be utilized for the Scheme as specified in *para* 1 above and the estimate of the expenditure is treated as maximum and every effort is made to effect such economy as possible and also that expenditure is incurred in accordance with the ceiling approved by the Government of India under different Heads.
6. This Sanction is issued in exercise of delegated powers and with the concurrence of Finance Division of Ministry of Agriculture, Department of Animal Husbandry, Dairying & Fisheries vide their Diary No. 2191/AS&FA dated 19.09.2018.
7. The audited figures of expenditure of the current financial year as well as previous years may please be furnished.


