Sub: Release of Funds as first instalment to State of Himachal Pradesh for implementation of Foot and Mouth Disease Control Programme (FMD-CP), under Centrally Sponsored Scheme "Livestock Health & Disease Control" during 2017-18 –regarding.

Sir,

I am directed to convey the sanction of the President of India for the payment of Grants-in-Aid amounting to Rs. 406.00 Lakhs (Rupees Four Crore Six Lakhs only) as Central Grants to the Department of Animal Husbandry & Veterinary Services of State Government of Himachal Pradesh and Uttarakhand as first instalment of 90% Central share for procurement of FMD vaccine and towards meeting expenditure on logistics for carrying out vaccination under Foot and Mouth Disease Control Programme (FMD-CP) during 2017-18 with the condition that matching 10% State share is to be provided by the State Governments so as to carry out vaccination of all eligible animals as envisaged under the programme as per schedule of vaccination.



5. The central funds may be utilized strictly as per approved activities & Budget for the year. If any inter component re-appropriation becomes necessary, prior approval of the Govt. of India should be obtained.
6. This Sanction is issued in exercise of delegated powers and with the concurrence of Finance Division of Ministry of Agriculture, Department of Animal Husbandry, Dairying & Fisheries vide their Diary No. 1078/AS&FA dated 07.06.2017.
7. It is certified that the expenditure of Rs. 406.00 Lakhs (Rupees Four Crore Six Lakhs only) has been duly noted in the Expenditure control register at Serial No. 17 to 18 on Page No.13 as stipulated in rule 234 of GFR 2017.
8. It is certified that no Utilization Certification is pending with the above-mentioned States as due for rendition under the Rules under the Scheme.


