Reference notes from pre-pages.

2. The proposal relates to concurrence sought for release of Rs.1143.00 lakhs (Rs.753.00 lakhs under MH 3601 SCSP + Rs.390.00 lakhs under MH 3601(TSP) to 18 States as mentioned in column 9 & 10 of table at page-6/n under the component "Honorarium to Enumerators and Supervisors" for conducting 20th Livestock Census during 2018-19.

3. The above proposal of the division for release of Rs.1542.92 lakhs at page-1-2/n was examined by IFD/Budget on page-2-3/n and the division was asked to furnish the actual head wise anticipated requirement of the scheme within the RE provision of Rs.5200.00 lakhs in the prescribed format as requested in Budget Section letter dated 17.01.2019. In response, the division has resubmitted the above proposal for release of Rs.1143.00 lakhs on page-6-7/n on which Budget Section has mentioned that funds are available within the RE provision under MH 3601 SCSP and TSP for the proposal.

4. The division has stated that the matter regarding release of funds under SCSP and TSP for disbursing honorarium to enumerators and supervisors for 20th Livestock census was discussed in SOM meeting held on 28.01.2019. Accordingly, the division has calculated the proposed release fund on the percentage population of SC and ST in various States based on Census 2011 in a table at page-6/n. The eligible funds and the released fund earlier to these 18 States may be seen at column 6 & column 7 in a table on page-6/n respectively. The funds are available under the relevant budget head as per RE 2018-19 which may be seen in a table on page-7/n. The proposal has the approval of Adv(Stat).

5. In view of the above, IFD may concur in the proposal for release of Rs.1143.00 lakhs (Rs.753.00 lakhs under MH 3601-SCSP + Rs.390.00 lakhs under MH 3601-TSP) to 18 States as mentioned in column 9 & 10 of table at page-6/n under the component "Honorarium to Enumerators and Supervisors" for conducting 20th Livestock Census during 2018-19 as proposed by the division subject to compliance of approved guidelines/norms of 20th Livestock Census and the condition that release may be made by the division strictly in accordance with D/o Economic Affairs OM dated 21.08.2017 regarding Cash Management in Govt of India.

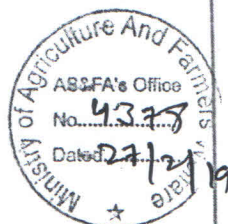
