- 5. The central funds may be utilized strictly as per approved activities & Budget for the year. If any inter component re-appropriation becomes necessary, prior approval of the Govt. of India should be obtained.
- 6. This Sanction is issued in exercise of delegated powers and with the concurrence of Finance Division of Ministry of Fisheries, Animal Husbandry & Dairying, Department of Animal Husbandry& Dairying vide No. 683/SS&FA dated 18/12/2020
- 7. It is certified that the expenditure of Rs. 7.88 Lakh (Rupees Seven Lakh Eighty eight Thousand Only) has been duly noted in the Expenditure control register at Serial No. 10 on Page No. 67as stipulated in GFR rule212(4)(b).
