Sub: Release of Funds as First instalment to States of Andhra Pradesh, Bihar, Goa, Gujarat, Madhya Pradesh, Telengana, Uttar Pradesh, Rajasthan, Karnataka, Kerala, Uttarakhand, Chhattisgarh and Himachal Pradesh for implementation of Foot and Mouth Disease Control Programme (FMD-CP) under Centrally Sponsored Scheme "Livestock Health & Disease Control" during 2018-19 –regarding.

Sir,

I am directed to convey the sanction of the President of India for the payment of Grants-in-Aid amounting to Rs. 1178.50 (Rupees Eleven Crore ^{lakh} seventy-eight lakh and fifty thousand only) as Central Grants to the Department of Animal Husbandry & Veterinary Services of State Government of Andhra Pradesh, Bihar, Goa, Gujarat, Madhya Pradesh, Telengana, Uttar Pradesh, Rajasthan, Karnataka, Kerala, Uttarakhand, Chhattisgarh and Himachal Pradesh as first instalment of 60% for Andhra Pradesh, Bihar, Goa, Gujarat, Madhya Pradesh, Telengana, Uttar Pradesh, Rajasthan, Karnataka, Kerala and Chhattisgarh and 90% for Uttarakhand and Himachal Pradesh as Central share for procurement of FMD vaccine and towards meeting expenditure on check posts and logistics for carrying out vaccination under Foot and Mouth Disease Control Programme (FMD-CP) during 2018-19 with the condition that matching 40% State share is to be provided by the State Governments of Andhra Pradesh, Bihar, Goa, Gujarat, Madhya Pradesh, Telengana, Uttar Pradesh, Rajasthan, Karnataka, Kerala and Chhattisgarh and 10% for State Government of Uttarakhand and Himachal Pradesh so as to carry out vaccination of all eligible animals as envisaged under the programme as per schedule of vaccination. The funds have been released to implement Special Component Plan for Schedules Tribes as under:
