Sub: Centrally Sponsored Scheme "Peste des Petits Ruminants – Control Programme" (PPR-CP), a component of Centrally Sponsored Scheme 'Livestock Health and Disease Control'- Release of Central Assistance during the year 2016-17 to the Himachal Pradesh State Govt. – regarding.

Sir,

I am directed to refer to the subject cited above and to convey the sanction of the President of India for the payment of Grants-in-Aid amounting to Rs. 20,00,000/- (Rupees Twenty Lakh only) to the Himachal Pradesh State Govt. towards expenditure on the Centrally Sponsored Scheme "Peste des Petits Ruminants – Control Programme" (PPR-CP), a component of Centrally Sponsored Scheme 'Livestock Health and Disease Control' for the current Financial Year (2016-17)) with the condition that 10% share is provided by the State Government.

2. The Grants-in-Aid of Rs. 20,00,000/- (Rupees Twenty Lakh only) have been released in accordance with the approved pattern of financial assistance under the Scheme. The release to the Himachal Pradesh State Govt. has been made with the condition that the next instalment for release will be considered only after obtaining the information relating to fund-utilization and submission of Utilization Certificate by the Himachal Pradesh State Govt.

3. The expenditure will be debited to the following Head of Accounts:

The payment of the amount during the Financial Year 2016-17 is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance letter No. 2(19)/F.II/60 dated 09.10.1964. The actual figures of expenditure duly audited by the Accountant General may be furnished to this Ministry as early as possible.

7. The audited figures of expenditure of the current financial year as well as previous years may please be furnished.


8. It is certified that no Utilization Certification is pending with the above mentioned states / UTs as due for rendition under the Rules under the scheme.


