## Subject: - Release of Non-Recurring Central Assistance to Government of <u>Himachal</u> <u>Pradesh</u> for repair of 4973 (3082 for 2020-21 and 1891 for the year 2019-20) Kitchen cum Stores during the financial year 2020-21.

Government of India has decided to revise the norms for Construction of Kitchen-cum-Store under the Mid Day Meal Scheme on the basis of State Schedule of Rates and plinth area norm. The cost of construction of Kitchen-cum-Store will be shared between the Centre and the NER States on 90:10 basis.

2. Government of **Himachal Pradesh** has sent a proposal for repair of 4973 (3082 for 2020-21 and 1891 for the year 2019-20) Kitchen-cum-Stores in the State. The unit cost of Kitchencum-Store as per State Schedule of Rate and as per plinth area norms. The total funds required for **repair of 4973 (3082 for 2020-21 and 1891 for the year 2019-20)** has been worked out as **Rs. 447.57 lakh** out of which 90% central share is **Rs. 170.19 lakh for repair of** 1891 Kitchen cum Stores during 2019-20 and **Rs. 277.38 lakh for** repair of **3082** Kitchen cum Stores under MDM Scheme during 2020-21 and 10% mandatory matching State share is **Rs. 18.91 lakh and Rs. 30.82 lakh**.

3. It has been decided to release of Rs. 447.57 lakh (Rupees Four Crore Forty Seven Lakh and Fifty Seven Thousand Only) to the State Government of Himachal Pradesh for repair of 4973 (3082 for 2020-21 and 1891 for the year 2019-20) Kitchen-cum-Stores under National Programme of Mid Day Meal in Schools for the year 2020-21. This amount is to be trifurcated into the following heads:-

(i) Rs. 300.05 Lakh will be debited to Demand No. 58 - Department of School Education & Literacy, 3601 (Major Head) – Grant-in-Aid to State Governments, 06 – Centrally Sponsored Schemes (Sub-Major Head), 101 – Central Assistance (Minor Head), 10 – National Programme of Mid Day Meals in Schools (Sub Head), 10.02 – Assistance to States Amount to be met from Prarambhik Shiksha Kosh (Detailed Head), 10.02.35 – Grants for Creation of Capital Assets for 2020-21(Plan).

(iii) Rs. 24.66 Lakh will be debited to Demand No. 58 - Department of School Education & Literacy, 3601 (Major Head) – Grant-in-Aid to State Governments, 06 – Centrally Sponsored Schemes (Sub-Major Head), 796 – *Tribal Area Sub Plan (Minor-Head), 10* - National **Programme of Mid Day Meals in Schools** (Sub Head), 10.02 – Assistance to States Amount to be met from Prarambhik Shiksha Kosh (Detailed Head), 10.02.35 – Grants for Creation of Capital Assets for 2020-21(Plan).

4. Accordingly, I am directed to convey the sanction of the President of India to release of **Rs. 24.66 Lakh (Rupees Twenty Four Lakh and Sixty Six Thousand only)** to Govt. of **Himachal Pradesh** as Non-recurring Central assistance under National Programme of Mid Day Meal in Schools for the year 2020-21.

5. The expenditure of Rs. 24.66 Lakh (Rupees Twenty Four Lakh and Sixty Six Thousand only) will be debited to Demand No. 58 - Department of School Education & Literacy, 3601 (Major Head) – Grant-in-Aid to State Governments, 06 – Centrally Sponsored Schemes (Sub-Major Head), 796 – *Tribal Area Sub Plan (Minor-Head), 10 -* National Programme of Mid Day Meals in Schools (Sub Head), 10.02 – Assistance to States Amount to be met from Prarambhik Shiksha Kosh (Detailed Head), 10.02.35 – Grants for Creation of Capital Assets for 2020-21(Plan). <u>3601.06.796.10.02.35</u>.

6. The above release is subject to the condition that total funds available for replacement of Kitchen Devices should be utilized during the financial year 2020-21 only.

7. A register of Assets acquired out of this grant shall be maintained as per rules.

8. It is certified that the pattern of assistance under the Scheme has the prior approval of Ministry of Finance, Government of India. It is also certified that this grant is being released in conformity with the rules and principles of the Ministry of Finance.

9. No Utilization Certificate is pending upto 2019-20 under Mid Day Meal Scheme with the State Government of Himachal Pradesh.

10. The accounts of the grantee shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and Internal Audit by the Principal Accounts Office of the Ministry of Education, Department of School Education and Literacy, whenever the grantee is called upon to do so.
