Subject - Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA) - on account payment of 3rd part of 1st tranche of Central Assistance for Financial year 2016-17 to the State Government of Himachal Pradesh.

Sir,

I am directed to convey the sanction of the President of India to the payment of Grants-in-aid amounting to Rs. 31,12,80,000/- (Rupees Thirty One Crore Twelve Lakh Eighty Thousand Only) to the State Government of Himachal Pradesh as Central assistance for implementation of the MGNREGA for the financial year 2016-17 and liquidating the pending liability of material component for FY 2015-16.

2. The State Government must transfer these funds along with the State share to the State Employment Guarantee Fund for programme implementation within 3 days positively from the date of receipt of these funds. In case of non transfer beyond this period, Central Government may be constrained to stop further releases. Besides, the State Government would be liable to pay interest @ 12% for the period of delay beyond the specified period. The State Government is requested to endorse the copy of the release order to the Central Government addressed as under;

- 3. Further the following conditions shall be fulfilled in utilisation of these funds:
 - a) In all Electronic Fund Management system (eFMS) 'implemented' areas, the funds shall be maintained at the State level; and there shall be no intermediary accounts. All payments in these areas shall move directly from the State fund to the destination accounts based on the pay order generated at the Block/Gram Panchayat level.
 - b) Where eFMS is not yet implemented, steps shall be taken to implement the same at the earliest.
 - c) The detailed voucher-based data shall be available in the NREGASoft for all the expenditure done.
 - d) The material component including wages of skilled and semi-skilled labour shall not exceed 40% at GP level, and in the case of Implementing Agencies at the district level.
 - e) This grant is towards plan expenditure and shall be utilized for approved items of works subject to the conditions laid down in the MGNREGA Guidelines. No deviation from the provisions of the Guidelines is permissible.

- No Utilization Certificate is pending against the Recipient Organization under the 4. Scheme.
- The accounts of the grantee institutions will be audited by the Comptroller and 5. Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 211 (1) of the General Financial Rules.
- The expenditure is debitable to the following Head of Accounts under Demand No. 75 Department of Rural Development (2016-2017).
