
2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No. 10 (1)-PF-I/76 dated 22nd January, 1977.
3. The grant-in-aid is subject to the following terms and conditions:-

shall ensure that the Institute is provided funds at the earliest

... after the grant of the institution is audited by the
Government to satisfy themselves that the account has been spent for the purpose
for which the grant has been sanctioned. The utilization certificate and audited
statement of accounts should be furnished for each financial year separately in the
format as prescribed in the GFR.

- i) The State should phase and plan the expenditure so as to keep within the sanctioned grants for the purpose.
4. The Institute shall follow all the financial management systems of the Government and shall submit Audit Reports, Utilization Certificates, Quarterly Summary on Concurrent Audit, FMRs/SOEs and Statement of Funds Position, showing unspent balances, funds released as advances, interest earned on unspent balance as and when due.

The expenditure covered by this sanction will met from the funds provided under Demand No. 42, 3601 - Grants-in-aid to State Government (Major Head); 06101 - Central Assistance/Share (Minor Head); 21 - Tertiary Care Programme/Schemes; 2104 - National Programme for Health Care of the Elderly; 210431 - Grants in Aid General (New) under Ministry of Health & Family Welfare during 2017-18.
6. The grants-in-aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No. 2 (90)-P.II/66 dated 9.10.1966.


