Sir,

I am directed to convey the sanction of the President of India to the release of additional amount of the 1st installment of the following non-recurring Grants-in-aid, totaling to Rs.249,44,00,000/- (Rupees two hundred forty nine crore forty four lakh only) to the following State Governments under the Centrally Sponsored Scheme of Establishment of New Medical Colleges attached with District/Referral hospitals:

The expenditure is debitable to Demand No.42, Department of Health & Family Welfare 3601 Grants-in-aid to State Governments (Major Head) 02 Grants for State Plan Schemes (Sub-Major Head) 02226 Medical Education, Training & Research (Minor Head) 01 Human Resources for Health & Medical Education 0106 Establishing New Medical Colleges (Upgrading District Hospitals) 010635 Grants for creation of Capital Assets (Plan) for the financial year 2016-17.

3. The grant-in-aid is subject to the following terms and conditions:-
- (i) The grant-in-aid should be utilized for the purpose for which it has been sanctioned.
 - (ii) The grant-in-aid is subject to the conditions and principles laid down in Rule 206 to 215 of the General Financial Rules, 2005 and instructions there under, modified from time to time as well as other specific conditions that may be circulated from time to time.
 - (iii) The accounts of the grantee institution/organization shall be open to inspection by the sanctioning authority and audit both by the Comptroller and Auditor General of India under the provisions of the CAG (DPC) Act, 1971 and internal audit by Chief Controller of Accounts of the Ministry, whenever the institution is called upon to do so.
 - (iv) The grantee institution is not authorized to divert the grants or entrust the execution of the scheme for which the grant is made for another purpose. In case of it not being in a position to execute or complete the assignment, it should forthwith refund to the Central Government the entire amount of the grant received by it.
 - (v) Institution receiving funds under Pradhan Mantri Swasthya Suraksha Yojana (PMSSY) will not be eligible for funding under the present scheme.
 - (vi) The State Government would furnish utilization certificate to the Central Government of the installments and also ensure that it has released its share under the scheme.
 - (vii) The State Government must ensure proper implementation of the Memorandum of Understanding (MoU) signed by it with the Central Government under the Scheme.
4. The amount of Rs.249,44,00,000/- (Rupees two hundred forty nine crore forty four lakh only) shall be transferred to State Governments through Reserve Bank of India as per procedure laid down by Ministry of Finance, Department of Expenditure vide O.M. No.F-II(45/76/SC) dated 22.2.1977.
