Sir,

I am directed to refer to this Ministry's sanction order issued under the File No. CW-II 22/147/2015-CW-II (1) dated 20.03.2024 on the subject mentioned above and to convey the sanction of the President of India for release of grants-in-aid amounting to **Rs.3,37,35,636/- (Rupees Three Crores Thirty-Seven Lakhs Thirty Five Thousand Six Hundred Thirty Six only)** out of total sanctioned amount of **Rs. 6,74,71,272/-** as central share to the State Government of Himachal Pradesh during current FY 2023-24, as per the details given in the table below:

3. The above-mentioned grant is subject to the under mentioned conditions: -

[A] Service Delivery Structure:

[i] **State Child Protection Society [SCPS]:** As approved, recurring grant including salary of staff has been provided for FY 2023-24 as per Scheme norms. Fund for Innovative Project is also provided.

[ii] **District Child Protection Units (12 existing DCPUs):** As approved, recurring grant including salary of staff has been provided for 12 DCPUs for the FY 2023-24 as per Scheme norms. Non - recurring grant has not been provided as it was earlier released in 2022-23

[iii] **State Adoption Resource Agency [SARA]:** As approved, recurring grant including salary of staff has been provided for FY 2023-24 as per MV norms. Non recurring grant has not been provided as it was earlier released in 2022-23.

[B] Institutional Services:

[i] **Government run Homes with 25 Capacity:** As approved, recurring grants including salary of staff has been calculated for the 03 existing Govt. run Homes as per actual number of staff position and as per actual number of beneficiaries as per Mission Vatsalya norms for FY 2023-24 **(Annexure -I).**

[ii] **Government run Homes with 50 Capacity:** As approved, recurring grants including salary of staff has been calculated for the 09 existing Govt. run Homes as per actual number of staff position and as per actual number of beneficiaries as per Mission Vatsalya norms for FY 2023-24 **(Annexure -I).**

It is submitted that the grant has been provided for 01 existing Home namely Balika Ashram Mashobra Children Home -II at Shimla District out of Existing Home because State Government Has Submitted JJ Registration certificate for FY 2023-24. It is also submitted that 01 existing Home Namely Institute for Children with Special Abilities (ICSA) Children Home -II at Mandi District out of the existing Home grant has not been provided because state has not furnished certificate of registration under JJ Act,2015 for this home **(Annexure -I).**

[iii] **NGO run Homes with 25 Capacity:** As approved, recurring grant including salary of staff has been calculated for the 03 existing NGO run Homes as per actual number of staff position and as per actual number of beneficiaries as per Mission Vatsalya norms for FY 2023-24 **(Annexure -I).**

[iv] **NGO run Homes with 50 Capacity:** As approved, recurring grant including salary of staff has been provided for the 10 existing NGO. run Homes as per actual number of staff position as per actual number of beneficiaries as per Mission Vatsalya norms for FY 2023-24. **(Annexure -I).**

It is submitted that the grants have been provided for the 02 newly created Homes at Divya Manav Jyoti Bal Ashram cum Children Home-II, Dehar at Mandi and Shanti Niketan Chhatravas Thethong Subathu Solam Children Home-II at Solan District out of the existing Homes because state has submitted certificate of registration under JJ Act,2015 for these homes. **(Annexure -I).**

[v] **Open Shelters in Urban and Semi Urban Areas:** As approved Recurring grant including salary of staff has been calculated for the 04 existing NGO. Run Open Shelter as per actual number of staff position and as per actual number of beneficiaries as per Mission Vatsalya norms for FY 2023-24. **(Annexure -I).**

[C] Statutory Services:

[i] **Child Welfare Committees [12 CWCs]:** As approved recurring grant for 12 CWCs including salary for Assistant cum Data Entry Operator have been provided for the financial year 2023-24 based on the actual number of sittings and as per actual number of date of appointment as per Mission Vatsalya Scheme norms.

[ii] **Juvenile Justice Boards [12 JJBs]:** As approved, recurring grant for 12 JJBs including salary for Assistant cum Data Entry Operator have been provided for the financial year 2023-24 based on the actual number of sittings and as per actual number of date of appointment as per Mission Vatsalya Scheme norms.

4. The Government of Himachal Pradesh shall reflect the amount in the audited statement of accounts together with the necessary Utilization Certificate and Statement of Expenditure in respect of the above grants and submit the same to this Ministry immediately after the close of the current financial year 2023-24.


5. The Utilization Certificate and Statement of Expenditure in respect of the above grants shall be furnished in accordance to Rule 239-240 GFR 2017 and in the Form 12C of GFR 2017. The provision of Rule 241 GFR 2017 shall also be ensured.

6. The accounts of all grantee Institutions or Organizations shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organization is called upon to do so.

7. Institutionalization of child, as per Section 3(xii) of the Guiding Principles of the JJ Act 2015, should be measure of last resort. As such non-institutional method like Sponsorship, Foster Care and Adoption should be given due priority.

8. Constitution/recognition of JJB, CWC, SARA, SAA and DCPU per district and one Place of Safety, SCPS per State, as per JJ Act, and its effective functioning shall be ensured.

9. Expenditure on existing Homes shall be strictly as per need and utilization of full capacity of Homes as per Mission Vatsalya Scheme norms. Accordingly, rationalization/merger of Homes, wherever required, may be carried out.

10. Registration of NGOs on Nitti Aayog portal and settlement of past UCs as per MOF OM No. 7(1)/E. Coord/2012 dated 14.11.2012 should be mandatorily ensured.

11. The amount of grant-in-aid is finally adjustable in the books of the Principal Pay and Accounts Officer, Ministry of Women & Child Development, D-Wing, Ground Floor, Shastri Bhawan, New Delhi. The payment of the State Governments would be arranged through CAS, Reserve Bank of India, Nagpur. The State Accountant Generals will send intimation regarding receipt of grant-in-aid to the Principal Pay & Accounts Office, Ministry of Women & Child Development, D-Wing, Ground Floor, Shastri Bhawan, New Delhi.

12. The expenditure involved is debatable to major head 3601: Grant in aid to the State Governments; 06-Centrally Sponsored Scheme; 101-Central Assistance/Share; 81-Mission Vatsalya; 00- Mission Vatsalya; 31-Grants-in-aid General; Demand No. 101, Ministry of Women & Child Development for the year 2023-24.
