- [iii] The accounts of all grantee Institutions or Organizations shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG(DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organization is called upon to do so.
- [iv] Expenditure on CCIs shall be strictly as per need and as per schematic norms.
- [v] Registration of NGOs on NITI Aayog portal and settlement of past UCs as per MOF OM No. 7(1)/E.Coord/2012 dated 14.11.2012 should be mandatorily ensured.
- [vi] The Grant-in-aid for Swachchata Action Plan during current FY 2024-25 is in the ratio of 90:10 (Centre: State).
