Subject: Central share of grants-in-aid to the States (other than North Eastern States) for Sponsorship under the scheme namely "Mission Vatsalya" (Child Protection Services and Child Welfare Services) for the current financial year of 2021-22.

Sir,

I am directed to convey the sanction of the President of India for release of grants-in-aid amounting to **Rs. 8,63,25,000/- [Rupees Eight Crore Sixty Three Lakhs and Twenty Five Thousand only]** as Central share of grants-in-aid for sponsorship during current financial year 2021-22 under the Centrally Sponsored Scheme, namely, **"Mission Vatsalya" (Child Protection Services and Child Welfare Services)** to the States (other than North Eastern States) as per details given below:

2. The above sanction is subject to the condition that Grant be disbursed to all NGOs provided that they are duly registered on the Darpan Portal of NITI Aayog and on PFMS and all requirements as per guidelines of the Government for release of funds to NGOs be fully complied with.
3. The above-mentioned grant is subject to the under mentioned conditions:-
- This amount of sponsorship @ Rs. 2000/- per child released to the States/UTs will be adjusted during releasing full & final instalment for the current FY 2021-22.
 - This fund will be for providing support to a family to enable a child to continue to remain in the family, continue his/her education. Children within institutions can also be restored to families with sponsorship assistance.
 - This fund will be for providing support in education of children in CCIs suffered due to the pandemic and suggested that infrastructure available in the CCIs for providing education to children needs to be assessed.
 - If the released amount is surplus to any district, the surplus amount can be used for other recurring expenditure as per CPS norms.
 - The Utilization Certificate and Statement of Expenditure in respect of the above grants shall be furnished in accordance to Rule 239-240 GFR 2017 and in the Form 12 C of GFR 2017. The provisions of Rule 241 GFR 2017 shall also be ensured.
 - The accounts of all grantee Institutions or Organizations shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG(DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organization is called upon to do so.
 - Institutionalization of child, as per Section 3(xii) of the Guiding Principles of the JJ Act 2015, should be a measure of last resort. As such non-institutional method like Sponsorship, Foster Care and Adoption should be given due priority.
 - Registration of NGOs on Niti Aayog portal and settlement of past UCs as per MOF OM No. 7(1)/E.Coord/2012 dated 14.11.2012 should be mandatorily ensured.
 - The Grant-in-aid for sponsorship during current year 2021-22 is in the ratio of 60:30:10 (in case of NGO run Child Care Institutions). In case of Himachal Pradesh and Utrakhhand the ratio is 90:10.

4. This recurring grant also includes the additional CCIs approved by PAB and was informed to the State governments of Gujarat, Rajasthan and Uttarakhand, vide this Ministry's letter dated 31.03.2021.
5. The amount of grant-in-aid is finally adjustable in the books of the Principal Pay and Accounts Officer, Ministry of Women and Child Development, D-Wing, Ground Floor, Shastri Bhawan, New Delhi. **The payment of the State Governments would be arranged through CAS, Reserve Bank of India, Nagpur.** The State Accountant Generals will send intimation regarding receipt of grant-in-aid to the Principal Pay & Accounts Office, Ministry of Women and Child Development, D-Wing, Ground Floor, Shastri Bhawan, New Delhi.
6. The expenditure involved is debitable to major head 3601: Grant in aid to the State Governments; 06-Centrally Sponsored Scheme; 101-Central Assistance/Share; 81-Mission Vatsalya; 00- Child Protection Services; 31-Grants-in-aid General; Demand No. 100, Ministry of Women & Child Development for the year 2021-22.
