2. The above sanction is subject to the condition that Grant be disbursed to all NGOs provided that they are duly registered on the Darpan Portal of NITI Aayog and on PFMS and all requirements as per guidelines of the Government for release of funds to NGOs be fully complied with.

3. The above-mentioned grant is subject to the under mentioned conditions:-

[i] **State Child Protection Society (SCPS)** : As approved, recurring grant including salary of staff has been provided for FY 2021-22 as per CPS norms. Grant-in-Aid for Supporting innovative Project has been not provided

[ii] **District Child Protection Units (12 existing DCPUs)** : As approved, recurring grant including salary of staff has been calculated for 12 DCPUs for the FY 2021-22 as per CPS norms. The State has requested Sponsorship and Foster care fund, as per CPS norms (i.e. Rs. 10.00 Lakhs) for all 12 DCPUs, therefore grant is provided as per CPS norms.

[iii] **State Adoption Resource Agency (SARA)** : As approved, recurring grant for 12 months of 2021-22 for SARA has been provided as per CPS norms. Staff salary has been calculated as per date of appointment.

[iv] **Care, Support and Rehabilitation Services :**

**NGO run Open Shelter (3 existing 1 New Approved )** : As approved, recurring grant for 3 existing Open Shelters has been provided for complete year 2021-22 as per CPS norms. PAB has approved one new NGO run Open Shelter run by Association for Social Health in India (ASHI) at Shimla for the current FY 2021-22. Non-recurring grant and recurring grant including salary of staff has been provided for FY 2021-22 as per CPS norms and as per actual number of beneficiaries (**Annexure-I**).

[v] **Non-Institutional Services:**

**NGO Run SAAs (1 existing):** As approved, recurring grant including salary of staff has been calculated for 1 existing NGO run SAA for complete FY 2021-22 as per CPS norms (**Annexure-I**).

[vi] **Institutional Services:**

**Government run Homes (11 existing) :** As approved, recurring grants including salary of staff has been calculated for the 11 existing Homes (9 Children's Home and 2 Observation Home cum Special Homes) **including 1 Specialized Unit for Special Need Children**, for complete FY 2021-22 as per actual number of beneficiaries and as per CPS norms **(Annexure-I)**.

**NGO run Homes (21 existing) :** As approved, recurring grant including salary of staff has been calculated for 21 existing Children Homes for complete FY 2021-22 as per actual number of beneficiaries and as per CPS norms **(Annexure-I)**.

[vii] **Statutory Support Services:**

**Child Welfare Committees [12 existing CWCs]:** As approved, recurring grant for 12 CWCs including salary for Assistant cum Data Entry Operator have been calculated for the complete financial year 2021-22 based on the actual number of sittings, as per CPS norms. The State has informed that the total number of sittings in CWCs is 20 per month. The meeting allowance/honorarium of the Chairperson and members of the CWCs has been provided on the basis of number of sittings.

**Juvenile Justice Boards [12 existing JJBs]:** As approved, recurring grant for 12 JJBs including salary for Assistant cum Data Entry Operator have been calculated for the complete financial year 2021-22 based on the actual number of sittings, as per CPS norms. The State has informed that the total number of sittings in JJBs is 12 per month. The grant has been provided as per CPS norms.

[viii] The Government of Himachal Pradesh shall reflect the amount in the audited statement of accounts together with the necessary Utilization Certificate and Statement of Expenditure in respect of the above grants and submit the same to this Ministry immediately after the close of the current financial year 2021-22.

[ix] The Utilization Certificate and Statement of Expenditure in respect of the above grants shall be furnished in accordance to Rule 239-240 GFR 2017 and in the Form 12C of GFR 2017. The provision of Rule 241 GFR 2017 shall also be ensured.

[x] The accounts of all grantee Institutions or Organizations shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organization is called upon to do so.

[xi] Institutionalization of child, as per Section 3(xii) of the Guiding Principles of the JJ Act 2015, should be measure of last resort. As such non-institutional method like Sponsorship, Foster Care and Adoption should be given due priority.

[xii] Constitution/recognition of JJB, CWC, SARA, SAA and DCPU per district and one Place of Safety, SCPS per State, as per JJ Act, and its effective functioning shall be ensured.

[xiii] Expenditure on existing Homes shall be strictly as per need and utilization of full capacity of Homes as per ICPS norms. Accordingly, rationalization/merger of Homes, wherever required, may be carried out.

[xiv] Registration of NGOs on Nitti Aayog portal and settlement of past UCs as per MOF OM No. 7(1)/E.Coord/2012 dated 14.11.2012 should be mandatorily ensured.

3. The amount of grant-in-aid is finally adjustable in the books of the Principal Pay and Accounts Officer, Ministry of Women & Child Development, D-Wing, Ground Floor, Shastri Bhawan, New Delhi. **The payment of the State Governments would be arranged through CAS, Reserve Bank of India, Nagpur.** The State Accountant Generals will send intimation regarding receipt of grant-in-aid to the Principal Pay & Accounts Office, Ministry of Women & Child Development, D-Wing, Ground Floor, Shastri Bhawan, New Delhi.

4. The expenditure involved is debitable to major head 3601: Grant in aid to the State Governments; 06-Centrally Sponsored Scheme; 101-Central Assistance/Share; 81-Mission Vatsalya; 00- Child Protection Services; 31-Grants-in-aid General; Demand No. 100, Ministry of Women & Child Development for the year 2021-22.


