

Sir,

I am directed to convey the sanction of the President for the payment of Grants-in-aid of Rs. 10,71,00,000/- (Rupees ten crore seventy-one lakh only) under the Scheme for Modernization of State Police Forces (new name "Assistance to State for Modernisation of Police") during the current financial year 2019-20 to the State Governments **as per Annexure** for purchase of equipment/against the expenditure which will be incurred as per the approved State Action Plans of 2019-20.

2. This is to certify that the State Governments **as per Annexure** has an unspent balance out of the funds released under the MPF Scheme for the previous financial years upto 2017-18.
3. The payment of Rs. 10,71,00,000/- (Rupees ten crore seventy-one lakh only) **as per Annexure** may please be released to the State Governments through Reserve Bank of India transfer advice.
4. The expenditure involved is debit to Major Head 3601 - Grants-in-aid to State Governments (Major Head), 06 – Centrally Sponsored Scheme (Sub Major Head), 06.101 – Central Assistance/Share (Minor Head), 11- Modernisation of Police Forces, 11.01 – Modernisation of State Police Forces, 11.01.35 Grants for creation of Capital Assets, under Grant No. 48 - Police for the year 2019-20.

5. As per GFR Rule 211(i) the Accounts of all grantee institutions or organizations shall be open to inspection by the sanctioning authority and the IAW of MHA, whenever the institution or organization is called upon to do so. The UCs, however, shall be furnished on yearly basis in accordance with GFR conditions.
6. All the terms and conditions stipulated in the Administrative approval of the financial year 2019-20 have been followed.
7. All interest/other earnings accrued by organization against amount released shall be mandatorily remitted to the Consolidated Fund of India (CFI).
8. The amount of release has been curtailed to 75% of the allocation for the year, despite availability of requisite Utilization Certificates, since reports submitted by the Internal Audit parties for 3<sup>rd</sup> and 4<sup>th</sup> quarter of 2018-19 are to be looked into while releasing funds in excess of 75% of the allocation for the current year in terms of GFR 238(2). All the State Governments to ensure that recommendations/observations of Internal Audit parties will be fully implemented so as to qualify for release in excess of 75 % of the allocation.
9. The sanction has been issued with the concurrence of the Ministry's Integrated Finance Division vide CF No. 3458906 dated 11<sup>th</sup> June, 2019.
