I am directed to refer to the subject mentioned above and to convey the sanction of the President for the payment of Grants-in-aid of Rs. 1,14,75,000/- (Rupees One Crore Fourteen Lakh Seventy-Five Thousand only) under the Scheme of "Assistance to States and UTs for Modernisation of Police" (erstwhile Modernization of State Police Forces) during the current financial year 2024-25 to the Government of Himachal Pradesh **as per Annexure** for purchase of equipment/against the expenditure which will be incurred as per the approved Action Plan of FY 2024-25.

2. The payment of Rs. 1,14,75,000/- (Rupees One Crore Fourteen Lakh Seventy-Five Thousand only) to the Government of Himachal Pradesh **as per Annexure** may please be released to the State Government through Reserve Bank of India transfer advice.

3. The expenditure involved is debitable to Major Head 3601 - Grants-in-aid to State Governments (Major Head), 06 - Centrally Sponsored Scheme (Sub Major Head), 06.101 - Central Assistance/Share (Minor Head), 11- Modernisation of Police Forces, 11.01 - Modernisation of State Police Forces, 11.01.35 Grants for creation of Capital Assets, under Grant No. 51 - Police for the year 2024-25.

4. As per GFR Rule 236 (i) the Accounts of all grantee institutions or organizations shall be open to inspection by the sanctioning authority and the IAW of MHA, whenever the institution or organization is called upon to do so. The UCs, however, shall be furnished on yearly basis in accordance with GFR, 2017.

5. All the terms and conditions stipulated in the guidelines of the sub-scheme will be strictly adhered to by the State.
6. The prescribed administrative and financial rules/regulations, procedure of budgeting, accounting internal control, auditing shall be strictly adhered to by the State.
7. All interest/other earnings accrued by organization against amount released shall be mandatorily remitted to the Consolidated Fund of India (CFI).
8. The procedure for release of funds under the Centrally Sponsored Schemes and monitoring utilization of the funds released as circulated vide Department of Expenditure, Ministry of Finance's O.M. No. 1(13)PFMS/FCD/2020 dated 23.03.2021 shall be fully complied to by the State Government and Single Nodal Agency (SNA) for the scheme shall fulfill its obligations.
9. The sanction has been issued with the concurrence of the Ministry's Integrated Finance Division vide CF No. 3721941 Dated 08<sup>th</sup> January, 2025.


