
Sir,

I am directed to refer to the subject mentioned above and to convey the sanction of the President for the payment of Grants-in-aid of Rs. 1,97,08000/- (Rupees One crore ninety-seven lakh eight thousand only) out of HS/HM Contingency Reserve under the Scheme for Modernization of State Police Forces (new name "Assistance to States for Modernisation of Police") during the current financial year 2018-19 to the State Governments for setting up of Anti-Human Trafficking Units as per Annexure.

2. Sanction of the President is also conveyed to release of Rs.1,97,08000/- (Rupees One crore ninety-seven lakh eight thousand only) out of HS/HM Contingency Reserve to the State Governments as per Annexure against which the expenditure will be incurred in the above mentioned Scheme during 2018-19.

3. The payment of Rs. 1,97,08000/- (Rupees One crore ninety-seven lakh eight thousand only) to the State Governments for setting up of Anti-Human Trafficking Units as per Annexure may please be released to the State Governments through Reserve Bank of India transfer advice.

The expenditure involved is debitable to Major Head 3601 - Grants-in-aid to State Governments (Major Head), 06 - Centrally Sponsored Scheme (Sub Major Head), 06.101 - Central Assistance/Share (Minor Head), 11- Modernisation of Police Forces, 11.01 - Modernisation of State Police Forces, 11.01.35 Grants for creation of Capital Assets, under Grant No. 48 - Police for the year 2018-19.
