**Sub: - Release of sum of Rs. 18,73,84,000/- as grant-in-aid to the State Governments under the scheme for 'Crime and Criminal Tracking Network and Systems' (CCTNS) for financial year 2017-18.**


In regard to the request of the State Governments for further funds, I am directed to convey the sanction of the President for the payment of Rs. 18,73,84,000/- (Rupees Eighteen Crores Seventy Three Lakhs and Eighty Four Thousand Only) to the State Governments for further implementation of Crime and Criminal Tracking Network and System (CCTNS) for the current Financial Year 2017-18 towards activities such as PIM, SPMU, Networking etc. with the following breakup:

2. The above amount will be sent through ECS/Transfer Advice to the States. The State Governments have to transfer the above amount(s) to the implementing agency within 15 days of receipt from Central Government. Any delay would require State Governments to release the same with the interest, at prevalent bank rate of RBI, for the period of default.
3. The expenditure involved in this sanction is debitable to Demand No. 48 Police; 3601 Grants-In-Aid to State Governments (Major Head); 06.101 Central Assistance/Share (Minor Head); 11 Modernization of Police Forces; 07 Crime and Criminal Tracking Network Systems ; 35 Grants for creation of capital assets.
4. All grantee shall ensure that the disbursed funds are utilized as per the norms and GFR codal formalities, and should not lead to parking of funds. The State Governments are required to submit the Utilization Certificate for the amount released under this head in the prescribed per-forma (Form 12-C) on due date to Ministry of Home Affairs.
5. As per GFR rule 211(1) the accounts of all grantees shall be made open to inspection by the sanctioning authority and the Internal Audit Wing of MHA, whenever the grantees are called upon to do so.
6. The grant may be released to the respective State Governments immediately.
7. The sanction issues in exercise of the delegated power in consultation with Integrated Finance Division of this Ministry vide Dy. No. 3081088/F-IV dated 23/03/2018. FA Approval Number is 3081088 dated 23<sup>rd</sup> March 2018.
