
I am directed to refer to the subject mentioned above and to convey the sanction of the President for the payment of Grants-in-aid of Rs. 3,36,00,000/- (Rupees three crore thirty six lakh only), under the Scheme for Modernization of State Police Forces during the current financial year 2017-18 to the State Government of Himachal Pradesh for purchase of equipment under Non-Plan activities as per the approved action plan 2017-18 for Himachal Pradesh.

2. Sanction of the President is also conveyed to release of Rs. 3,36,00,000/- (Rupees three crore thirty six lakh only) to the State Government of Himachal Pradesh against which the expenditure will be incurred in the above mentioned Scheme during 2017-18.

3. This is to certify that the State Government of Himachal Pradesh has an unspent balance of Rs.44,00,000/- out of the funds released under non-plan head of the MPF Scheme for the previous financial years upto 2015-16.

4. The payment of . Rs. 3,36,00,000/- (Rupees three crore thirty six lakh only) may please be released to the State Government of Himachal Pradesh through Reserve Bank of India transfer advice.

The expenditure involved is debitable to Major Head 3601 - Grants-in-aid to State Governments (Major Head), 06 – Centrally Sponsored Scheme, 06.101 – Central Assistance/Share (Minor Head), 11- Modernisation of Police Forces, 11.01 – Modernisation of State Police Forces, 11.01.35 Grants for creation of Capital Assets, under Grant No. 48 - Police for the year 2017-18.


