2. The above amount is being released to the State Government based on the recommendation from M/o Home Affairs vide O.M. No. 9-4/2022-NDM-I dated 14th September, 2022. The release is being made on an "on Account basis" to the State Government of Himachal Pradesh.

3. RBI may be requested to **credit** the above amount into the account of the State Government immediately.

4. The Release of Fund will be governed by the Operational Guidelines on Constitution and Administration of the **NDRF** based on the recommendations of 15th Finance Commission issued vide Ministry of Home Affairs' letter No.33-03/2021-NDM-I dated 12th January, 2022.

5. The above release would follow normal accounting procedure. As such, the amount is to be debited to **Major Head-2245-Relief on Account of Natural Calamities, 80-General Relief on Account of Natural Calamity-Assistance to State from National Disaster Response Fund 103.02.00.31 in Demand No.42-Transfers to States.**
