Subject: Release of Grant-in-Aid to the State of Himachal Pradesh for implementation of New India Literacy Programme (NILP), a scheme of Adult Education during the FY 2023-24 – General Component- regarding.

Sir,

I am directed to say that the new scheme of Adult Education i.e. New India Literacy Programme (NILP) was approved by the Competent Authority for implementation in all the States/UTs in the country during the FYs 2022-23 to 2026-27. The meeting of the Project Approval Board (PAB) was held for consideration of the proposals (Physical and Financial) of 33 States/UTs on 04.05.2022 at Shastri Bhawan, New Delhi through video conferencing.

2. The PAB in its meeting had approved the coverage of **89,000 learners with a budget of Rs. 2,07,75,820/- (Central share: Rs. 1,86,98,238/- and State share: Rs. 20,77,582/-) for Himachal Pradesh during the FY 2022-23**. SLMA Himachal Pradesh submitted the final proposal for implementation of NILP in Himachal Pradesh covering **89,000 learners with a budget outlay of Rs. 1,55,81,112/- (Central share: Rs. 1,40,23,000/- and State share: 15,58,112/-)**. The component-wise details of financial ceiling, requirement of funds projected by SLMA, Himachal Pradesh and funds to be released vide this sanction by this Ministry for covering **89,000 learners** are as under:

3. The grant may be utilized for mobilization and environment building activities at State, district, Block & Gram Panchayat level, identification of non-literates to be covered under Basic Literacy Programme through door to door survey and compilation of names and other details of each individual non-literate learner in prescribed software, procurement of infrastructure for Adult Education Centres, constitution of different level of Committees at ZP, Block & GP levels, procurement of teaching learning material and management cost of the programme at SLMA, ZP and Block level in the district covered under the programme.

4. Accordingly, I am directed to convey the sanction of President for release of an amount of **Rs. 32,39,000** /- (Rupees Thirty-Two Lakh and Thirty-Nine Thousand only) (For General Component), [69.3% of First installment (Central Share) of **Rs. 46,74,000** /-] as central share to the Government of Himachal Pradesh for the year 2023-24 for implementation of NILP in 13 districts of Himachal Pradesh, as proposed in Annual Work Plan by Himachal Pradesh and approved by PAB.

5. The State Government of Himachal Pradesh, will immediately release the amount along with the matching State share to the Education department or nodal department for implementation of New India Literacy Programme (NILP). Education department or nodal department for New India Literacy Programme (NILP) must release the component-wise Central Assistance along with matching State share to the State Literacy Mission Authority of Himachal Pradesh **immediately**.

6. The amount will be debatable to Demand No.25, Department of School Education & Literacy, Major Head "3601"- Grants-in aid to State Govt., 06 – Centrally Sponsored Schemes, 101- Central Assistance/Share, 88- New India Literacy Programme 00.31 - Grants-in-aid General.


7. The amount of grant-in-aid is finally adjustable in the books of Principal Accounts Officer, Ministry of Education, Department of School Education and Literacy, D-Wing, Ground Floor, Shastri Bhawan, New Delhi. On receipt of sanction letter, the Principal Accounts Officer may issue an advice to the Reserve Bank of India (Central accounts Section), Nagpur for affording credit to the balance of

the State Government. The Principal accounts Officer may forward a copy to undersigned in the department of School Education & Literacy. State Government shall send intimation regarding receipt of grant-in-aid to Principal Accounts Officer, Ministry of Education, Department of School Education and Literacy, Shastri Bhawan, New Delhi.

8. This Grant-in-aid is subject to the further conditions indicated below:-

- (i) The Programme will be implemented in accordance with the Scheme Guidelines and such other instructions issued or which may be issued, by the National Literacy Mission Authority from time to time.
- (ii) The State share together with Central share must be released immediately by the State Government to their implementing agencies (IAs).
- (iii) All necessary actions are taken by States/UTs expeditiously and the Central share together with corresponding State share are utilized by them or their agencies, exactly as per the norms and financial parameters approved for the scheme, without delay to achieve the intended output and outcome of the Scheme envisaged for the current FY (2022-23).
- (iv) All the Committees at State/District/Block/village levels, as prescribed in the scheme, are set up by States/UTs for proper implementation of the scheme.
- (v) All monitoring mechanism at Centre/State/Distt/Block/village level as envisaged in the scheme for its proper implementation are put in place expeditiously;
- (vi) All infrastructures already set up in the previous scheme of 'Saakshar Bharat'/ Padhna Likhna Abhiyan, particularly at bock/village level like 'Adult Education Centre (AEC)' need to be utilized for this scheme. The benefit of convergence of the scheme with other ongoing Central schemes like MGNREGA, Skill Development, IEC etc. as envisaged in the scheme needs to be availed of;
- (vii) All States/UTs, where funds are being released, are required to obtain Utilization Certificates & Audited Statement of Accounts from their implementing agencies, on completion of FY 2023-24, and submit the same, after verification & authentication, to this Department.
- (viii) The Implementing Agency may be asked by State Governments to indicate if there is any unspent balance of central share available with them out of the previous scheme of 'Saakshar Bharat' and 'Padhna Likhna Abhiyan' so as to refund the same.
- (ix) The SLMA should closely monitor the programme and interact with the nodal officer in the NLMA on a regular basis for sending QPRs and MPRs in the such format and at such intervals as prescribed by the NLMA.
- (x) SLMA is also required to submit the physical and financial progress on line on MIS formats.
- (xi) The funds earmarked for particular component would be used for that specified component only. Diversion of funds earmarked for one component to another, is not permissible.
- (xii) The SLMA will facilitate physical inspection by NLMA or its authorized agencies.
- (xiii) NLMA will have the right to recall the unutilized amount at any point of time.
- (xiv) The accounts of grantee institutions or organizations shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and Internal Audit by the Principal Accounts Office of this Ministry whenever the institution or organization is called upon to do so.
