The State Govt. is requested to furnish the Utilization Certificates (UCs) in the prescribed proforma new **GFR-12-C** to this Department at the end of the financial year. It is also requested to submit Quarterly Progress Reports for both physical and financial achievements (indicating Central share and matching State share separately) regularly.

The accounts of the State Govt. in respect of National Food Security Mission shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the State Govt./institution is called upon to do so.

10. This sanction issues in exercise of the delegated powers in consultation with Finance Division of the Department of Agriculture, Cooperation & Farmers Welfare vide their **Dy. No. 40690/471/FTS/AS&FA dated 11/06/2018.**
