I am directed to convey the sanction of the President to the payment of grants-in-aid of **Rs.2,49,37,000/-** (Rupees Two Crore Forty Nine Lakh and Thirty Seven Thousand only) to the States towards the first installment of grants-in-aid for implementation of Infrastructure Maintenance, Urban FW Centres (UFWCs), a Centrally Sponsored Plan Scheme during 2018-19, as detailed below:

The expenditure covered by this sanction will be met from the funds provided under Major Head – 3601-Grants-in-aid to State Governments (Major Head); 06 – Centrally Sponsored Schemes (Sub-Major Head); 06789 – Special Component Plan for Scheduled Castes (Minor Head); 05 - FW-Infrastructure Maintenance; 05.03-Urban Family Welfare Centres(UFWCs); 05.03.31- Grants-in-aid – General in Demand No.42– Health & Family Welfare during 2018-19. This amount is for salary of regular staff of State Government as per Ministry of Health and Family Welfare Office Order No.P.17029/59/2012-NRHM-IV dated 25th May, 2012.

4. The grants-in-aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No.2 (90)-P.II/66 dated 9.10.1966.
