

I am directed to convey the sanction of the President to the payment of grants-in-aid of **Rs.92,29,02,000/- (Rupees Ninety Two Crore Twenty Nine Lakh and Two Thousand Only)** to the State of **Himachal Pradesh** towards liquidation of Arrears of 2017-18 for implementation of Infrastructure Maintenance (Sub-Centers), a Centrally Sponsored Plan Scheme during 2019-20. With this release, the arrears will be settled up to 2017-18.

This amount is for salary of regular staff of State Government under IM as per Ministry of Health and & Family Welfare Office Order No.P.17029/59/2012-NRHM-IV dated 25th May, 2012.
