- The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22<sup>nd</sup> January, 1977 and is to be paid in Cash.
- The States shall not make any changes in allocations or re-appropriations among different components/activities without approval of the MoHFW, GoI.
- The States shall ensure that 40% /10 % as applicable of its share based on release of funds by GOI is credited to appropriate accounts.
- The States shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summary on Concurrent Audit, FMRs/ SOEs and Statement of Funds Position, showing unspent balances, funds released as advances, interest earned on unspent balance as and when due.
- Grant-in-Aid shall be used for the purpose for which sanction is given. An annual utilization certificate (in Form **GFR 12C**) shall be furnished that the contribution has been utilized for the purpose for which it was sanctioned.
- The Provisional Utilization Certificates towards releases made during the year 2019-20 from the above States have been received.
- The sanction order is being issued in accordance with Rule 228 to 245 of General Financial Rules, 2017.
