Grant in-aid shall be used for the purpose for which sanction is given. An annual utilization certificate 6. (in Form GFR 12C) shall be furnished that the contribution has been utilized for the purpose for which it was sanctioned.

The sanction order is being issued in accordance with Rules 228 to 245 of General Financial Rules, 7. 2017.
