Subject: Release of First Installment of Grants-in-Aid under Flexible Pool for Communicable Diseases (NDCPs) for the year 2019-20 – **Sanction Reg.**

Sir,

I am directed to convey the sanction of the President of India for release of an amount of **Rs.16,58,00,000/- (Rupees Sixteen Crore and Fifty Eight Lakh Only)** to the following 3-(Three) States towards first Installment of Grants-in-Aid for implementation Revised National TB Control Programme (RNTCP), one of the National Disease Control Programme (NDCPs) under the **Flexible Pool of Communicable Diseases** during 2019-20.

2. The above amount is in accordance with the instructions issued by the Ministry of Finance (Plan Finance Division) vide their O.M. No.10(1)-PF-I/76 dated 22<sup>nd</sup> January, 1977 and is to be paid in Cash.
3. The States shall not make any changes in allocations or re-appropriations among different components/activities without approval of the MoHFW, GoI.
4. The States shall ensure that 40%/10% (as applicable) of its share based on release of funds by GOI is credited to appropriate accounts.
5. The States shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summary on Concurrent Audit, FMRs/ SOEs and Statement of Funds Position, showing unspent balances, funds released as advances, interest earned on unspent balance as and when due.
6. Grant in-Aid shall be used for the purpose for which sanction is given. An annual utilization certificate (in Form **GFR 12C**) shall be furnished that the contribution has been utilized for the purpose for which it was sanctioned.
7. The Provisional Utilization Certificates towards releases made during the year 2018-19 from the above three States have been received.
8. The sanction order is being issued in accordance with Rule 228 to 245 of General Financial Rules, 2017.
