- The expenditure covered by this sanction will be met from the funds provided under Major Head – 3601- Grants-in-aid to State Governments (Major Head); 06 – Centrally Sponsored Schemes (Sub-Major Head); 06101-Central Assistance/Share (Minor Head); 14-FW-Infrastructure Maintenance; 14.04-Auxiliary Nurse Midwife(ANM)/Lady Health Visitors(LHVs); 14.04.31- Grants-in-aid General in Demand No.42– Health & Family Welfare during 2019-20. This amount is for salary of regular staff of State Government as per Ministry of Health and & Family Welfare Office Order No.P.17029/59/2012-NRHM-IV dated 25th May, 2012.
