
3. The States shall not make any changes in allocations or re-appropriations among different components/activities without approval of the MoHFW, GoI.

4. The States shall ensure that 40%/10% as applicable of its share based on release of funds by GOI is credited to appropriate accounts.

5. The States shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summary on Concurrent Audit, FMRs/ SOEs and Statement of Funds Position, showing unspent balances, funds released as advances, interest earned on unspent balance as and when due.

6. Grant in-Aid shall be used for the purpose for which sanction is given. An annual utilization certificate (in Form **GFR 12C**) shall be furnished that the contribution has been utilized for the purpose for which it was sanctioned.

7. The Audited Utilization Certificates towards releases made during the year 2017-18 have been received from the above States.
