The State/UT shall follow all the financial management systems under NHM and shall submit Audit Reports, Utilization Certificates, Quarterly Summary on Concurrent Audit, FMRs/ SOEs and Statement of Funds Position, showing unspent balances, funds released as advances, interest earned on unspent balance as and when due. Audited Utilization Certificate for the FY 2019-20 has been received.
- 6. Grant in-aid shall be used for the purpose for which sanction is given. An annual utilization certificate (in Form **GFR 12C**) shall be furnished that the contribution has been utilized for the purpose for which it was sanctioned.
- 7. The sanction order is being issued in accordance with Rules 228 to 245 of General Financial Rules, 2017.
- 8. The expenditure involved is recurring and will be met from the funds provided under Major Head 3601 Grants-in-aid to State Governments (Major Head) 06 Centrally Sponsored Schemes (Sub-Major Head); 06.796 Tribal Area Sub Plan (Minor Head) 60 ASHA Benefit Packages (Sub-head); 60. 00 ASHA Benefit Packages; 60.00.31 Grants-in-Aid-General in Demand No.42 Health & Family Welfare during 2020-2021.
