- 6. Grant in-aid shall be used for the purpose for which sanction is given. An annual utilization certificate (in Form **GFR 12C**) shall be furnished that the contribution has been utilized for the purpose for which it was sanctioned.
- 7. The sanction order is being issued in accordance with Rule 228 to 245 of General Financial Rules, 2017.
- The expenditure covered by this sanction will be met from the funds provided under Major Head 3601- Grants-in-aid to State Governments (Major Head); 06 Centrally Sponsored Schemes (Sub-Major Head); 796 Tribal Area Sub Plan (Minor Head); 04- National Rural Health Mission 04.02-Health System Strengthening under NRHM; 04.02.31- Grants-in-aid General (New) in Demand No.42 Health & Family Welfare during 2017-18.
- The grants-in-aid now sanctioned is provisional and is subject to adjustment on the basis of audited figures of expenditure in terms of Ministry of Finance, Department of Expenditure, letter No.2 (90)-P.II/66 dated 9.10.1966.
