Sub:- Release of 1<sup>st</sup> tranche of 1<sup>st</sup> installment of administrative cost for the Financial Year 2023-24 for implementation of DDUGKY in the State of Himachal Pradesh by Himachal Pradesh State Rural Livelihoods Mission Society.-Regarding.  
Sir,

I am directed to convey the sanction of the President of India for the payment of grant-in-aid amounting to **Rs.6,44,000.00(Rupees Six Lakh Forty-four Thousand Only)** to the **State Government of Himachal Pradesh** towards 1<sup>st</sup> tranche of 1<sup>st</sup> installment of administrative cost for the Financial Year 2023-24 of Central share for implementation of DDUGKY in the State of Himachal Pradesh by Himachal Pradesh State Rural Livelihoods Mission Society. The amount proposed to be released is Rs.12,87,000.00, out of this, **Rs.6,44,000.00**(50% rounded off to nearest thousand) is being released under this order.

2. The State Government shall transfer its matching share as per fund sharing ratio of **90:10**, into concerned SNA,s account of Himachal Pradesh State Rural Livelihoods Mission Society, "**Account Name in Bank- M/S. DDUGKY HP SNA, Bank- ICICI Bank, Kasumpti Shimla., IFSC Code-ICIC0003668, Account No.366801000422**" positively within 21 days of its receipt. The Central share shall not be diverted to the Personal Deposit (PD) account or any other account by the State Government. The factum of release of these funds must be registered in the Public Financial Management System (PFMS). The State Government is requested to endorse a copy of the release order of funds to Himachal Pradesh State Rural Livelihoods Mission Society and to the Central Government addressed as under:-

4. DDO Skills (Code-208040) will be the Drawing and Disbursing Officer for this purpose. The Pay and Accounts Officer, Ministry of Rural Development (Tele: 011-23070539) is requested to release the amount **Rs.6,44,000.00(Rupees Six Lakh Forty-four Thousand Only)** to the State Government of Himachal Pradesh.
5. State shall follow/comply with the guidelines/procedure prescribed in Ministry of Finance, Department of Expenditure, OM No. F. No. 1(13)PFMS/FCD/2020 dated: 23.03.2021, 30.06.2021 and subsequent instructions issued in this regard from time to time.
6. The accounts of the SRLM will be open to audit by the Comptroller and Auditor General of India and the internal Audit of the Principal Accounts Office of the Ministry of Rural Development under Chief Controller of Accounts, in terms of Rule 236 (1) of the General Financial Rules 2017.
7. No Utilization Certificate is pending against Himachal Pradesh State Rural Livelihoods Mission Society under DDU-GKY.
8. The sanction of Administrative cost is subject to the following Terms and Conditions:
  - (a) The State shall appoint a dedicated Chief Operating Officer (COO) for Skills as per section 4.1.1 of DDUGKY guidelines within one month of the issuance of this Sanction order
  - (b) The State shall appoint eight State Project Managers (SPMs) to support COO (Skills) within four months of issuance of this sanction order to address the key functions like concurrent monitoring, Standards and Quality Assurance, Partnership Engagement, Training & Development, Mobilization & IEC, Post Placement Tracking, Project Appraisal and Fund releases.
  - (c) The State shall take action to onboard a Technical Support Agency (TSA) or an equivalent arrangement within six months of issuance of this sanction order for supporting capacity building, monitoring related activities to achieve the objectives of the programme.
9. This issues under the delegated powers of this Ministry and with the concurrence of its Integrated Finance Division vide their **U.O. No.787/Finance/2023-24/Dated:22.12.2023.**
