Subject: -Release of 1<sup>st</sup> installment of central share of funds of the Project Cost and Support Cost of Action Plan 2023-24 to the State Government of Himachal Pradesh for implementation of placement linked Skill Development Project under DDU-GKY by Himachal Pradesh State Rural Livelihoods Mission Society. -Reg.

Sir,

I am directed to convey the sanction of the President of India for the payment of grant-in-aid amounting to **Rs.13,03,00,000.00(Rupees Thirteen Crore Three Lakh Only)** to the State Government of Himachal Pradesh towards 1<sup>st</sup> installment of central share of funds of the Project Cost and Support Cost approved in Action Plan 2023-24 for implementation of placement linked Skill Development Project under DDU-GKY by Himachal Pradesh State Rural Livelihoods Mission Society. The amount of Central Share proposed to be released as the 1<sup>st</sup> installment is Rs.26,06,00,000.00, out of this, **Rs.13,03,00,000.00(50%)** amount for General Category including Minority is being released under this order.

2. The grant- in- aid shall be utilized for implementation of DDU-GKY projects as per terms and conditions laid down in the DDU-GKY Guidelines and Standard Operating Procedures (SOPs.) and extant instructions issued from time to time. No deviation from the provisions of DDU-GKY Guidelines and SOPs for implementation of DDU-GKY Projects is permissible.

3. The State Government shall transfer its matching share as per fund sharing ratio of **90:10**, into concerned SNA account of Himachal Pradesh State Rural Livelihoods Mission Society, "Account Name in Bank- M/S. DDUGKY HP SNA, Bank- ICICI Bank, Kasumpti Shimla., IFSC Code-ICIC0003668, Account No.366801000422" positively within 21 days of its receipt. The Central share shall not be diverted to the Personal Deposit (PD) account or any other account by the State Government. The factum of release of these funds must be registered in the Public Financial Management System (PFMS). The State Government is requested to endorse a copy of the release order of funds to Himachal Pradesh State Rural Livelihoods Mission Society and to the Central Government addressed as under:-
