I am directed to convey the sanction of the President of India for release of **Rs.11,25,86,000.00(Rupees Eleven Crore Twenty-five Lakh Eighty-six Thousand only)** as reimbursement of training cost of rural poor youths for the Financial Year FY 2019-20 (₹16.07 lakh), 2020-21 (₹147.31 lakh), 2021-22 (₹244.65 lakh), 2022-23 (₹348.85 lakh) and 2023-24 (₹368.98 lakh) to the State Government of **Himachal Pradesh** for RSETIs in the State.

2. The State Government shall transfer the funds to concerned SNA account of "**Himachal Pradesh State Rural Livelihood Mission, Account Holder Name: M/s. CEO HPSRLM RSETI, Bank Name- HDFC Bank Limited, Branch Name-Shimla, IFSC Code-HDFC0006405, Account No.50100439078816**" positively within 21 days from the date of receipt of the said funds. These funds shall not be diverted to the Personal Deposit (PD) account or any other account by the State Government. The factum of release of these funds must be registered in the Public Financial Management System (PFMS). The State Government is requested to endorse a copy of the release order of funds to Himachal Pradesh State Rural Livelihood Mission and to the Central Government addressed as under:-
