The State Government shall transfer its matching share as per fund sharing ratio of 90:10, into concerned SNA,s account of Himachal Pradesh State Rural Livelihoods Mission Society, "Acount Name in Bank- M/S. DDUGKY HP SNA, Bank- ICICI Bank, Kasumpti Shimla., IFSC Code-ICIC0003668, Account No.366801000422" positively within 21 days of its receipt. The Central share shall not be diverted to the Personal Deposit (PD) account or any other account by the State Government. The factum of release of these funds must be registered in the Public Financial Management System (PFMS). The State Government is requested to endorse a copy of the release order of funds to Himachal Pradesh State Rural Livelihoods Mission Society and to the Central Government addressed as under:-
