Subject: Release of **1<sup>st</sup> tranche of 1<sup>st</sup> installment of Central share** in respect of Startup Village Entrepreneurship Program (SVEP) umbrella projects implementation in the State of **Himachal Pradesh during FY-2024-25.**

Madam/Sir,

I am directed to convey the sanction of the President of India for the payment of grant-in-aid amounting to Rs1,00,00,000.-(**Rupees One Crore only**) to the **State Government of Himachal Pradesh** of Central share in respect of SVEP umbrella Projects implementation during **FY 2024-25.**

2. The State Government must transfer these funds along with the State share to the **M/S CEO HIMACHAL PRADESH STATE RURAL LIVELIHOODS MISSION SOCIETY, Bank Name – ICIC Bank, Branch - SCO 14 15 16 BLOCK NO.3 SDA COMPLEX KASUMPTI SHIMLA 171009, Ac/No – 366801000412, IFSC Code- ICIC0003668**, within 21 days of its receipt. Corresponding state share, should be released as early as possible, but not later than 40 days of release of Central Government's Share of Grant-in-Aid. The State Government is requested to endorse a copy of the release order to the Central Government addressed as under:

3. All other terms and conditions for implementation of the projects shall be as per the scheme guidelines, DPRs and the advisories issued by DAY-NRLM under the SVEP umbrella Projects.
4. The accounts of the SRLM will be open to inspection by the NMMU, NRLM Team and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act, 1971 and the internal Audit of the Principal Accounts Office of the Ministry of Rural Development under Chief Controller of Accounts, whenever it is called upon to do so, in terms of Rule 236 (1) of the General Financial Rules 2017.



5. The fund released should be utilised as per the EC approvals for the following components –

6. SRLM can submit the proposal for next tranche of fund with the confirmation that entire Central share released along with matching State share has been transferred from the State treasury to SRLM and there is 75% utilization of funds and as per the DoE guidelines.

7. The funding pattern will be 90:10 by the Centre and State.

9. Under Secretary (RL) will be the Drawing and Disbursing Officer for this purpose. The Pay and Accounts Officer, Ministry of Rural Development (Tele: 011-23070539) will transfer the amount mentioned in Para I to the **State Government of Himachal Pradesh**.

10. The UC for the grants earlier released which have become due as per provisions of the SVEP guidelines has been submitted by the SRLM and accepted by the Programme Division/Integrated Finance Division of this Ministry.

11. Assets acquired wholly or substantially out of this grant, except those declared as obsolete and unserviceable or condemned in accordance with the procedure laid down in the General Financial Rules, 2017, shall not be disposed of without obtaining the prior approval of this Ministry (Rule 230 (9) of GFR 2017).

12. All expenditure will be subject to the ceiling/ranges of the units and unit cost as communicated by the Ministry from time to time.

13. **SRLM Shall utilise the funds for fulfilling the targets as approved in the Minutes of the Empowered Committee held on 19/03/2024 which had approved the SVEP Umbrella projects AAP.**

14. The SRLM shall furnish a report about the progress of the activities, implementation of guidelines, expenditure incurred and such other progress statements as may be required by the Government of India.

15. For monitoring and periodic review of the sanctioned projects under SVEP Umbrella Project, a Committee needs to be formed at the State level, headed by the Mission Director, SRLM. This committee should undertake quarterly review of the projects approved under SVEP umbrella project. The minutes of such monitoring committee meetings should be shared with DAY-NRLM within 10 days of the meeting being held.
16. As per clarification given in the OM No. 1(13)/PFMS/fcd/2021 dated 30/06/2021 of DoE, MoF, Gol "The SNAs shall ensure that the interest earned from the funds released should be mandatorily refunded to the respective Consolidated Funds on pro-rata basis in terms of Rule230(8) of GFR, 2017. Interest earned should be clearly and separately depicted in PFMS, scheme-specific portals integrated with PFMS and in MIS provided by the banks". The SRLM shall comply with the above said OM and take necessary action for return of interest earned and furnish undertaking in the prescribed format, with the next proposal for release of funds.
17. SRLM will keep all the funds received in the Single Nodal Account (SNA) only and shall not divert the same to Fixed Deposits/Flexi-Account/Multi-Option Deposit Account/ Corporate Liquid Term Deposit (CLTD) Account etc.
18. It shall be the responsibility of the SRLM to exercise due diligence as per norms prescribed for scrutiny of the documents and accuracy of data before release of Central Government's Share of Grant-in-Aid to the various stake holders.
19. If in case, at any point of time, SRLM decides to discontinue the implementation of SVEP umbrella projects components, then all such unutilised amount of Grant-in-Aid shall be refunded back as per the approved mechanism of Government of India.
20. This issue under the delegated powers of this Ministry and with the concurrence of its Integrated Finance division on vide their UO No. 456/Finance/2024-25 dated 06.09.2024.
