I am directed to convey the sanction of the President of India for the payment of grant-in-aid amounting to Rs.20,09,700.00(Rupees Twenty Lakh Nine Thousand Seven Hundred Only) to the State Government of Himachal Pradesh towards 1st tranche of 1st installment of administrative cost of Central share for implementation of DDUGKY in the State of Himachal Pradesh by Himachal Pradesh State Rural Livelihoods Mission Society. In case of delay, the State government would be liable to pay interest@12% for the period of delay beyond the specified period.
