Sub:- Release of 1<sup>st</sup> tranche of 1<sup>st</sup> installment of administrative cost for the Financial Year 2020-21 for implementation of DDUGKY in the State of Himachal Pradesh by Himachal Pradesh State Rural Livelihoods Mission Society.-Regarding.  
Sir,

I am directed to convey the sanction of the President of India for the payment of grant-in-aid amounting to **Rs.20,09,700.00 (Rupees Twenty Lakh Nine Thousand Seven Hundred Only) to the State Government of Himachal Pradesh** towards 1<sup>st</sup> tranche of 1<sup>st</sup> installment of administrative cost of Central share for implementation of DDUGKY in the State of Himachal Pradesh by Himachal Pradesh State Rural Livelihoods Mission Society. It is informed that while concurring the release of funds, IFD has advised to release 1<sup>st</sup> installment in two tranches of 50% each of Rs.0.693 crore. 2<sup>nd</sup> tranche may be released only when the amount of 1<sup>st</sup> tranche along with corresponding state share is transferred to the account of HPSRLM. The amount proposed to be released is Rs.69,30,000.00, out of this, **Rs.20,09,700.00 (29% amount)** is being released under this order.

2. The State Government shall transfer its matching share as per fund sharing ratio of **90:10, into the account of Himachal Pradesh State Rural Livelihoods Mission Society - "CEO, HPSRLM, "Bank-HIMACHAL PRADESH STATE CO-OP.BANK LTD., Kasumpti Branch, Shimla-171009, IFSC Code-HPSC0000417, Account No.41710107423"** positively within 15 days from the date of receipt of the said funds. In case of delay, the State government would be liable to pay interest@12% for the period of delay beyond the specified period. The factum of release of these funds must be registered in the Public Financial Management System (PFMS). The State Government is requested to endorse a copy of the release order of funds to Himachal Pradesh State Rural Livelihoods Mission Society and to the Central Government addressed as ,under:-

4. The accounts of the grantee institutions will be open to audit by the Comptroller and Auditor General of India and the internal Audit of the Principal Accounts Office of the Ministry.
5. Section Officer (Skills) will be the Drawing and Disbursing Officer for this purpose. The Pay and Accounts Officer, Ministry of Rural Development (Tele: 011-23070539) is requested to release the amount of **Rs.20,09,700.00(Rupees Twenty Lakh Nine Thousand Seven Hundred Only)** to the State Government of Himachal Pradesh .
6. No Utilization Certificate is pending against Himachal Pradesh State Rural Livelihoods Mission Society under DDU-GKY.
7. The sanction of Administrative cost is subject to the following Terms and Conditions:
  - (a) The State shall appoint a dedicated Chief Operating Officer (COO) for Skills as per section 4.1.1 of DDUGKY guidelines within one month of the issuance of this Sanction order
  - (b) The State shall appoint eight State Project Managers (SPMs) to support COO (Skills) within four months of issuance of this sanction order to address the key functions like concurrent monitoring, Standards and Quality Assurance, Partnership Engagement, Training & Development, Mobilization & IEC, Post Placement Tracking, Project Appraisal and Fund releases.
  - (c) The State shall take action to onboard a Technical Support Agency (TSA) or an equivalent arrangement within six months of issuance of this sanction order for supporting capacity building, monitoring related activities to achieve the objectives of the programme.
8. This issues under the delegated powers of this Ministry and with the concurrence of its Integrated Finance vide their **U.O. No.726/Finance/2020-21/24.09.2020.**
